

## Terms and conditions of RAFA 2017 conference

### 1 Applicability

1. The 8<sup>th</sup> International Symposium on Recent Advances in Food Analysis is organised by the University of Chemistry and Technology, Prague (UCT Prague, Czech Republic) and RIKILT Wageningen UR (Wageningen, the Netherlands). ### 2 Agreement

1. Once you have registered for the meeting, you will receive confirmation about your registration by e-mail.

### 3 Cancellation

1. Only written cancellations can be accepted, to be sent to [RAFA2017@vscht.cz](mailto:RAFA2017@vscht.cz).
2. Cancellation of participation in the conference:  
Cancellation before September 1, 2017 – refund 75%; no refunds after that date.  
Where an individual fails to attend and has not cancelled in advance, the full conference costs are also payable.  
It is acceptable to send a substitute to the meeting.

### 4 Changes to the program, location of the conference

1. Where there is good reason to do so, the organizer is entitled to change the location of the conference. Attendees will then be permitted to withdraw.
2. Where there is good reason to do so, the conference may be cancelled; any charges that have already been paid will be refunded. No claims for compensation above and beyond this will be valid. Irrespective of this, the organizer may cancel the meeting up to 14 days before it starts without giving a reason.
3. In case of force majeure, neither party may hold the other liable for any delay to or non-performance of the agreement which results from this force majeure.
